**A. Permit Fees**

The following fees are assessed to an applicant applying for coverage under the Virginia Stormwater Management Program (VSMP) Authority Permit. Fifty percent (50%) of the total fees shall be due at the time that a stormwater management plan is submitted to the County for review. The remaining total fee balance shall be paid by the applicant prior to the issuance of the coverage under the VSMP Authority Permit.

**B. Modification/Transfer Fees**

VSMP Authority Permit modification or transfer fee: The following fees shall apply to modifications or transfers of individual VSMP Authority Permits. If the VSMP Authority Permit modification result in changes to the stormwater management plans that require additional review by the County, such reviews shall be subject to fees set out in this section. The fee assessed shall be based on the total disturbed acreage of the site. In addition to the VSMP Authority Permit modification fee, modifications resulting in an increase in total disturbed acreage shall be assessed the difference in the initial VSMP Authority Permit fee paid and the VSMP. **All modification or transfer submissions require completion of both a Registration Statement and Permit Fee Form.**
