UPON NOTIFICATION BY THE COURT (granted, not granted, new date); **NOTIFY ALL INVOLVED IN THE CASE**, to include attorneys, guardian ad litems, probation officers, witnesses, etc.

Upon the granting of a continuance, the Clerk's office will re-summon those persons summoned for the original hearing date. The Clerk's office will not subpoena witnesses without a completed subpoena request form. It is the attorneys' or the pro se litigant's responsibility to notify the Court of the names of those witnesses who do not need to be subpoenaed for the new hearing date.
