## Planning Commission Policy for Installation of Sidewalks in Major Subdivisions

Section 15-22 of the Subdivision Ordinance, establishes criteria for installation of sidewalks in major subdivisions within Gloucester County. During implementation of these criteria, the Planning Commission recognized that clarification was needed regarding the extent to which sidewalks should be required pursuant to this section of the Ordinance. After numerous discussions, the Planning Commission agreed upon a policy, which sets forth specific criteria for sidewalks in major subdivisions. The following policy was adopted by the Planning Commission on February 5, 2004 and will be in effect until further notice.

<sup>&</sup>lt;sup>2</sup> ADT for determining the sidewalk requirement should use that proposed for the new subdivision road plus traffic from existing or potential development that may use the proposed subdivision road. Where there is uncertainty over the potential level of traffic generated, the Planning Commission shall require the higher standard.
